(iv) **Description:** Primary (non-rechargeable) 3.7 V Lithium Thionyl Chloride (Li-SOCI₂) hybrid battery, assembled from 2 (two) "D" size cell and 1 (one) HLC-1520 in parallel connection. The battery is designed to preclude violent rupture under normal conditions incident to transport. The TLP-93321/A battery may come with optional suffixes consisting of a "/" followed by one or more letters and a digit. These suffixes indicate different types of finishing to the battery, e.g., harness.
